Wet Road Conditions Lead To Car Accidents

Driving in the rain can be a very uncomfortable feeling for a lot of drivers. Especially on the days that the rain comes down so hard that windshield wipers simply cannot keep up. For Kansas City area drivers we face 93 days of rain a year on average. During that time period we face around 37 inches of rainfall. This can lead to a very treacherous driving endeavor – a circumstance that lawyers at Castle Law Office, as well as personal injury lawyers in Kansas City can attest to.

When it rains the grease, oil and dirt build up in the ground during dry periods. The rain releases all of these materials, creating very slippery road conditions. Rain water on top of asphalt can cause tires to lose their traction, contributing to the danger. The plus side of a good rain shower is that the oil and grease will be washed off the road and driving can be much safer.

There are plenty of preemptive measures that you can take to increase your safety on the road and decrease the likelihood of getting into a car accident. The first thing to look at is your windshield wipers. Are they leaving streaks? Do they have any rips or wear to them? If so, they need to be replaced. Make sure to check your tire pressure. Over-inflated or under-inflated tires can be very dangerous especially in wet conditions. Make sure your tire pressure is at the recommended psi for your make and model of tire. A great tip is that if your windshield wipers are being used, your headlights need to be turned on. This will allow other drivers to see you easier. Decreasing your speed will decrease the likelihood of you being in a car accident.

Workers Compensation affects many residents in the Kansas City area each year. Below you will find some facts that will help you in a workers compensation settlement.

- Generally you have 20 days in KS and 30 days in MO to report your injury.
- You are entitled to reimbursement for mileage to and from doctors visits.
- Insurance companies will monitor your social media behavior.
- Your employer is required to provide a list of doctors for you to choose.
- In 2016 MO wage cap is currently 886.92 a week and KS is \$610 a week.
